DECISION

Pursuant to art. 155 of the *Act dated June 14th 1960 - Code of Administrative Procedure* (i. e. *Dz.U. [Journal of Laws] of 2023, pos. 775, as amended*), art. 56, clause 2 and clause 4, item 6 and 7 in relation to art. 52, clause 1, item 1, 2, 3, 7, 8, 9, 12, 13 and 15 of the *Environmental Protection Act dated April 16th 2004* (i. e. *Dz. U. [Journal of Laws] of 2014, pos. 916, as amended*), § 2 and §3, and § 6, clause 1, 2, 3, 7, 8, 9, 12, clause 2 and 3 of the *Regulation of the Minister of Environment dated December 16th 2016* on the fauna species protection (i.e. *Dz.U. [Journal of Laws] of 2022, pos. 2380*), having considered the application dated April 17th 2023, as sent by Mrs. Joanna Kabarowska, acting under the authority vested by the Director of RZGW [Regional Authorities for Water Management] in Wrocław (power of attorney No.WR.ROO.0120.39.2021.KK dated 14.04.2021), regarding the change of the decision, file No. WPN.6401.268.2016.IL of August 26th 2016, changed by the decision No. WPN.6401.327.2020.MH of November 23rd 2023 on extending the permit expiry date,

I hereby decide

to change the decision issued by the Regional Director for Environmental Protection in Wrocław, No. WPN.6401.268.2016.IL of August 26th 2016, changed by the decision No. WPN.6401.327.2020.MH of November 23rd 2023, in a way that the wording included in the sentence

“The permit expires on June 30th 2023.

I hereby oblige the Applicant to provide the Regional Director for Environmental Protection in Wrocław with a report on the permit utilization scope until **each 15th January** of the decision validity year, while the last report shall be submitted by July 15th 2023”.

shall get the following wording:

“The permit expires on June 30th 2024.

I hereby oblige the Applicant to provide the Regional Director for Environmental Protection in Wrocław with a report on the permit utilization scope until each **15th January** of the decision validity year, while the last report shall be submitted by July 15th 2024”.

The remaining content of the decision shall remain unchanged.

JUSTIFICATION

On April 17th 2023 the Regional Directorate for Environmental Protection in Wrocław was provided with the application of Mrs. Joanna Kabarowska, acting for and on behalf of the Director of the Regional Authorities for Water Management in Wrocław, related to changing the decision No. WPN.6401.268.2016.IL of August 26th 2016, changed by the decision No. WPN.6401.327.2020.MH of November 23rd 2023 on extending the permit expiry date.

Pursuant to the application, changing the permit expiry date is due to rescheduling the completion date for the construction works involving the Szalejow reservoir, implemented under the investment titled *Construction of a dry flood control reservoir on the Bystrzyca Dusznicka River in Szalejow*.

Thus, bearing in mind the party's legitimate interest, is has been decided as stated above.

Information

The parties may appeal against the decision to the General Director for Environmental Protection through the Regional Director for Environmental Protection in Wrocław within 14 days of its delivery date.

Pursuant to art. 127a of the Code of Administrative Procedure, during the course of the period specified for the appeal the Party may revoke the right to appeal against a public administration authority that has issued the decision.

Upon the date of submitting the statement about waiving the right to appeal by the last party to the procedure to the public administration body, the decision becomes final and binding.

PLN 41.00 administrative fee has been charged for the decision, pursuant to part III, clause 46, item 1 of the appendix to the Stamp Duty Act dated November 16th 2006 (i.e. Dz. U. [Journal of Laws] of 2022, pos. 2142, as amended).
