NOTICE

Pursuant to Art. 122c § 1 Act as of 14 June 1960 of the Polish Code of Administrative Procedure, Journal of Laws [Dz.U.] of 2018, item 2096 as amended), in conjunction with Art. 118, par. 6 point 1 of the Nature Conservation Act as of 16 April 2004, Journal of Laws [Dz.U.] of 2018, item 1614 as amended) after examining the application as of 27.02.2019 (received 27.02.2019, reg. no.: POPDOW-ZPT.072.1.2019) from Mrs Krystyna Araszkiwicz, Sweco Consulting Sp. z o.o., ul. Łyskowskiego 16, 71-641 Szczecin, on spoil silting from the bottom of Klucz-Ustowo cut (the Skośnica) on the length of about 2.7 km, on plots no. 26, 32, 423/2, 23, 24, 15 (boundary 0008, Kołbaskowo adm. district), and 108 (boundary 0031, Gryfino adm. district).

and the authorities do not file any objection thereto**

Grounds

On 27 February 2019, Mrs Krystyna Araszkiwicz, Sweco Consulting Sp. z o.o., ul. Łyskowskiego 16, 71-641 Szczecin, filed a notification on the intent to carry out works vesting in silting spoil from the bottom of Klucz-Ustowo cut (the Skośnica) on the length of about 2.7 km on plots no. 26, 32, 423/2, 23, 24 15 (boundary 0008, Kołbaskowo adm. district), and 108 (boundary 0031, Gryfino adm. district).

The activities planned by the applicant constitute „Komponent 1B.4 Zadanie: Bagrowanie przekopu Klucz-Ustowo” /Component 1B.4 Task: Dredging of the Klucz-Ustowo cut). The area of the project under discussion is wholly located within the territory of the Lower Odra Valley Landscape Park and Natura 2000: Lower Odra Valley PLB320003 and Lower Odra PLH320037.

For the activity the component Authority issued a notice of No Objection of May 30, 2018 (reg. no.: WOPN-ON.670..52.2018.BO,PW). The necessity of re-notification is driven by introduction of additional, unplanned before, minimisation measures for protection of stands of the water caltrop (*Trapa natans*) located in vicinity of the area of planned works (Obnica Północna canal).

Upon analysis of the application, the local authority decided not to file any objection against implementation of the above mentioned works, resulting out of Art. 118 of the Act of 16 April 2004 on Nature Conservation.

Therefore, the notice is issued pursuant to Art. 122c § 1 Act as of 14 June 1960 of the Polish Code of Administrative Procedure (Journal of Laws [Dz.U.] of 2018, item 2096 as amended).

Pursuant to Art. 118 of the Act of 16 April 2004 on Nature Conservation the works covered by the notice can be commenced not later than 2 years following the date of commencement of works stipulated in the notice.
