Subject: Letter no. POPDOW-ZP.066.43.2019 of 9.05.2019 (date of receipt: 13.05.2019) on objects and areas under conservation protection along the indicated section of railway line no. 203 Tczew-Kostrzyn nad Odrą in the town of Kostrzyn nad Odrą.

With reference to the letter in question, the Provincial Heritage Conservation Officer for Lubuskie Province informs that the planned investment will be carried out on the site of the former Royal Eastern Railway established in 1857. The following monuments are located along railway line no. 203 Tczew-Kostrzyn nad Odrą, in the section from the bridge on the river Warta at 341.375 km to the border bridge on the river Odra at 342.289 km whose range is marked in red on the map attached to the application:

- 1. A fragment of the Kostrzyn Fortress entered into the register of monuments by the decision of 18.12.1963 under the register number 639 and by the decision of 2.11.1976 under the register number KOK-I-81/76;
- 2. A railway bridge over the so-called Suchodół from 1926 (plot no. 61, locality 0006 Stare Miasto) included in the provincial records of monuments, not entered in the register of monuments;
- 3. A railway bridge on the river Warta from 1857 (plot 2/1, locality 0006 Stare Miasto) included in the provincial records of monuments, not entered in the register of monuments.

The Kostrzyn Fortress is subject to legal protection pursuant to art. 7 (1) of the Act of 23 July 2003 Old Monuments Law (consolidated text: Journal of Laws of 2018, item 2067 as amended). Therefore, in order to undertake any activities specified in art. 36 (1) of the cited act in this area, the permission of the Provincial Heritage Conservation Officer is required.

Occupation earth is also protected on the site of the Kostrzyn Fortress. Therefore, archaeological research will be required in the case of earthworks in this area. Pursuant to Art. 36 (1)(5) of the Old Monuments Law, a permit for the research needs to be obtained from the Provincial Heritage Conservation Officer.

Planned investments in the area of the abovementioned bridges included in the provincial records of monuments, not entered in the register of monuments, will require consultation with the Provincial Heritage Conservation Officer through the competent municipality authority or architectural and building administration authority.

This opinion is only of a substantive nature and does not release from the obligation to obtain relevant permits and approvals specified in detailed provisions.
