## DECISION

Pursuant to applied to Art. 104 of the Act of 14th June 1960 of the Administrative Procedure of the Act Code (unified text *Journal of* Laws of 20220 item 256 as amended).and the Art. 72A of 3 October 2008 on *disclosing information on the environment and its protection, public participation* in environmental protection and environmental impact assessments (unified text *Journal of* Laws of 2020 item 283 as amended).

## I am transferring

the decision on the environmental conditions, ref. no.: GN.6220.10.13.2019.MKu of 02.03.2019 for the project named "Reconstruction of the road bridge in Krosno Odrzańskie in km 514.1 of the Odra River, implemented as part of the Odra-Vistula Flood Management Project "Task 1 B.1 (b)", issued for the State Water Holding Polish Waters with its seat in ul. Grzybowska 80/82 00-844 Warszawa. The transfer is made with the consent of the State Water Holding Polish Waters with its registered office in Warsaw to the General Director for National Roads and Motorways, ul. Wronia 53, 00-874 Warsaw, which accepts all the conditions contained in the decision on the environmental conditions, ref. no.: GN.6220.10.13.2019.MKu of 02 March 2019.

## GROUNDS

On 08.05.2020, the Mayor of Krosno Odrzańskie received an application from Mr. Bartosz Kańtoch, representing the State Water Holding Polish Waters Regional Water Management Authority in Wrocław and the General Director for National Roads and Motorways, presenting the statements of the above mentioned parties, in which they express their willingness to transfer the decision on environmental conditions of the ref. no.: GN.6220.10.13.2019.MKu of 02.03.2019 issued for State Water Holding Polish Waters with its registered office in Warsaw for the General Director for National Roads and Motorways, ul. Wronia 53 00-874 Warszawa. Only the entities between whom the transfer is to be made shall be parties to the transfer proceedings. Parties to the proceedings - General Director for National Roads and Motorways, ul. Wronia 53, 00-874 Warsaw accepts all the conditions contained in the decision on the environmental conditions, ref. no.: GN.6220.10.13.2019.MKu of 2 March 2019 (statement ref. no. : O.ZG.Z-4.4110.1,74.a.2020.di of 01.06.2020,), and the party - State Water Holding Polish Waters with its registered office in Warsaw - agrees to the transfer of the decision (statement of 20/05/2020). Meeting the requirement Art. 104 of the Act of 14<sup>th</sup> June 1960 of the Administrative Procedure Code (unified text *Journal of* Laws of 2020 item 256 as amended) and the Art. 72A of the Act of 3<sup>rd</sup> October 2008 *on making available the information on environment and its protection and on environment impact assessments (unified text Journal of* Laws of 2020 item 283 as amended), taking into account in full the applicant's request, the Mayor ruled as in the initial part of the decision.

## Instruction

- 1. This Decision does not create rights to land and does not violate the property rights and rights of third parties.
- 2. There is a right to appeal the decision to the Local Government Appeal Board in Zielona Góra through the Mayor within fourteen days of its delivery.

3. During the period for the appeal, a party may waive the right to appeal against the public administration which issued the decision.

4. On the date on which the declaration is submitted by the last party to proceedings, to the public administration body, the decision shall become final and binding.
