DECISION

Under Art. 113 § 1 of the *Administrative Procedure Code* of June 14th, 1960 (Journal of Laws: Dz. U. of 2016 item 23), in relation to Art. 71 Par. 2 Subpar. *1 of the Act of October 3rd, 2008 on the Provision of Information on the Environment and its Protection, Public Participation in Environmental Protection and Environmental Impact Assessments (Journal of Laws: Dz. U. of 2013 item 1235 as amended),*

I decide to

rectify routinely an obvious mistake in clause I.2.1. of the decision issued by me on December 18th, 2015 (ref. no.: WOOŚ.4233.1.2015.AW.23) for the project entitled: "Construction of Roztoki Bystrzyckie dry flood control reservoir on the Goworówka Stream near Roztoki, Międzylesie Municipality, Lower Silesian Province". The wrong period of commencing the earthworks and construction works provided due to the mistake is hereby corrected as follows:

the period entered by mistake: "before/after the period from August 15th to March 15th"

is replaced with the correct period: "in the period from August 15th to March 15th".

Justification

On December 18th, 2015, the Director issued a decision on the environmental conditions (ref. no.: WOOŚ.4233.1.2015.AW.23) for the project entitled: "Construction of Roztoki Bystrzyckie dry flood control reservoir on the Goworówka Stream near Roztoki, Międzylesie Municipality, Lower-Silesian Province".

The authority's own analysis of that decision revealed that, due to a typographic mistake, the decision provided a wrong permissible period of commencing the earthworks and construction works: it was indicated that the works should "commence before/after the reproduction period of the animals" (which imposed an obligation to commence the works in the period from August 15th to March 15th), but the same clause simultaneously indicated that the works should commence "before/after the period from August 15th to March 15th". That provision made the condition specified in clause I.2.1 of the decision in question contradictory and unfeasible.

Therefore, one had to rectify the obvious mistake.

Consequently, it was ruled as stated above.

Instruction

The parties may appeal against this decision to the General Director for Environmental Protection via the authority that issued the decision within 7 days of the delivery date.
