### **Opinion of the conservator**

In response to the letter of 26.10.2016 (date of registration 28.10.2016) supplemented by a letter dated 26.10.2016 (date of registration 02.11.2016) together with a technical design for issuing an opinion for the investment named: ***'Vistula Stage 2 - Expansion of the right embankment of the Vistula river over a length of 13.959 km, the right embankment of the San river over a length of 2.193 km and the left embankment of the Łęg river over a length of 0.112 km, within the communes of Gorzyce and Radomyśl nad Sanem, the Podkarpackie Province included: Section I with the Section San – right embankment of the Vistula river in km 286+816 – 279+416, on the section in km 0+000 – 7+205 Radomyśl nad Sanem Commune, Stalowa Wola District and right embankment of the San river in km 0+239 – 2+276, on the section 0+000 – 2+193 Radomyśl nad Sanem Commune, Stalowa Wola District. Section II - right embankment of the Vistula river in km 278+750 – 273+650, on the section km 0+000 – 4+889 Gorzyce Commune, Tarnobrzeg District. Section III - right embankment of the Vistula river in km 273+783 – 271+806, on the section km 0+000 – 1+865 Gorzyce Commune, - left embankment of the Łęg river in km 0+770 – 0+900 of the Łęg river on the section 0+000 – 0+112, Gorzyce Commune, Tarnobrzeg District in the Podkarpackie Province'*** as well as the act of 8<sup>th</sup> July 2010 on particular terms of preparation and implementation of Projects with regard to flood-control structures (consolidated text: Journal of Laws of 2015, item 966, as amended), the Provincial Office for the Preservation of Monuments in Przemyśl Office in Tarnobrzeg informed that **reviews positively**, from the point of view of the monument preservation, submitted design, provided that it shall include therein in the scope of protection of monuments inviolability of the plot No. 1714/3 in Wrzawy, Gorzyce Commune located near Section II ca. km 4+880 of the investment. On this plot located in the immediate vicinity of the investment area, is located the

mound with the monument founded in 1879 by Kalikst Horoch which commemorates the battle fought at this place between the troops led by Józef Poniatowski, the Polish Prince and Ferdinand, the Austrian Archduke in 1809. The war cemetery dated 1809 is located around the monument. Consequently, the protection of the monument and the war cemetery (included in the communal register of monuments of the Gorzyce Commune) is recommended under Article 22 of the act of 23 July 2003 on historical monuments law (consolidated text, Journal of Laws of 2014, item 1446, as amended).

Moreover, there are no other monumental objects in the area covered by the submitted Design and in its immediate vicinity [except m/a the cemetery], or archaeological sites.
