DECISION

On the basis of Article 72a in connection with Article 75 Par. 1 Subpar. 1 letter i) of the Act of 3 October 2008 on providing information on the environment and its protection, public participation in environmental protection and environmental impact assessments (Journal of Laws of 2008, No 199, item 1227 as amended) , in connection with Article 104 of the Act of 14 June 1960 – Administrative Procedure Code (Journal of Laws of 2000, No 98, item 1071, as amended), after considering the application submitted on June 25th, 2012 by Mr. Tadeusz Kowalewski, a representative of Biuro Projektów Inżynierii Środowiska i Melioracji “EKOPROJEKT” Sp. z o.o. in Zielona Góra, acting on behalf of the Lubuskie Province,

I transfer

the decision of the Regional Director for Environmental Protection in Gorzów Wielkopolski of February 16th, 2011, ref.: WOOS-II.4233.2.2011.TK
on the environmental conditions for the undertaking entitled:

Nowa Sól – Pleszówek – stage I – construction of the left-bank embankment for the Odra river at chainage km 429.85÷432.40 and embankments of the Czarna Struga river at chainage km 0+000÷3+330”

in favour of the Lubuskie Province,
Podgórna St. No 7, 65-057 Zielona Góra.

GROUND

On the 26th of June 2012, Mr. Tadeusz Kowalewski, a representative of Biuro Projektów Inżynierii Środowiska i Melioracji “EKOPROJEKT” Sp. z o.o. in Zielona Góra, acting on behalf of the Lubuskie Province, submitted to the Regional Director for Environmental Protection in Gorzów Wielkopolski an application for transferring of the decision of February 16th, 2011 ref: WOOS-II.4233.2.2011.TK on the environmental conditions for the undertaking entitled:

Nowa Sól – Pleszówek – stage I – construction of the left-bank embankment for the Odra river at chainage km 429.85÷432.40 and embankments of the Czarna Struga river at chainage km 0+000÷3+330” from the Lubuski Board of Amelioration and Hydraulic Structures in Zielona Góra, Ptasia St. No 2B, 65-514 Zielona Góra, in favour of the Lubuskie Province, Podgórna St. No 7, 65-057 Zielona Góra.

Duly authorised applicant stated that the Lubuski Board of Amelioration and Hydraulic Structures in Zielona Góra, i.e. the party in favour of which the aforementioned decision on environmental conditions was issued, gave its consent to transfer it in favour of the Lubuskie Province. Whereas, the Lubuskie Province accepts all conditions included in the decision in question.

Pursuant to Article 72a Par. 1 of a/m Act on providing information on the environment and its protection, public participation in environmental protection and environmental impact assessments, the authority competent to issue decisions on environmental conditions is obliged, by consent of the party in favour of which the decision was issued, to transfer such a decision in favour of other authority, provided that it accepts all conditions included therein.

Finding the submitted application legitimate and acting on the basis of above-cited regulations, it was decided as stated hereinabove.

INSTRUCTION

The parties may appeal against the decision to the General Director for Environmental Protection in Warsaw via the Regional Director for Environmental Protection in Gorzów Wielkopolski within 14 days from the date of delivery.
