The State Water Holding Polish Waters Regional Water Management Authority in Wrocław (SWH Polish Waters RZGW in Wrocław), Project Implementation Unit of the Odra-Vistula Flood Management (PIU) has made available to the interested persons and institutions **DRAFT ANNEX NO. 3 TO THE ENVIRONMENTAL MANAGEMENT PLAN** for *Contract 2A.1/1 Construction of a dry polder on the Nysa Kłodzka in the village of Boboszów* (hereinafter referred to as **DRAFT ANNEX NO. 3 TO THE ENVIRONMENTAL MANAGEMENT PLAN**) executed under Component 2 – *Flood protection of the Kłodzka Valley, Subcomponent 2A - Active protection*.
