The State Water Holding Polish Waters Regional Water Management Authority in Rzeszów informs that in December 2020 or in the 1st quarter of 2021 it is planned to hand the site over and to commence the construction works at Contract no. 3D.3 Leg IV – extension of the left embankment at km 0+082-5+030 in the Gorzyce commune and the right embankment at km 0+000-5+236 in the Gorzyce commune.

### **Description of the Task**

The planned task remains within the framework of the Odra-Vistula Flood Protection Project (OVFMP). Implementation of the Project is co-financed by the International Bank for Reconstruction and Development (World Bank), Council of Europe Development Bank (CEB), European Union's Cohesion Fund (IEOP 2014-2020), and the State Budget.

The aim of the Project is to improve flood protection for inhabitants living within selected area of the Odra River-Basin and of the Upper Vistula River-Basin against summer floods and winter floods, and flash floods. That aim is also relevant for implementation of the Works Contract 3D.3, which is to secure flood protection through extension of the River Łęg embankments in the following reaches: km 0+000 to km 5+236 of the right embankment, and km 0+082 to km 5+030 of the left embankment. That measure is necessary for improvement of flood safety, protection of inhabitants, and limitation of flood damage within the Commune of Gorzyce.

The planned works mainly comprise raising the of existing embankment crest at the River Łęg. In case of the left embankment of the River Łęg it shall be provided mostly (4 362 m) by raising the landside (external) slope, whereas raising the right embankment's crest shall mostly (5 087 m) be done through raising the riverside slope (relocation of the crest toward the embanked area), what limits the land acquisition.

Decision of the Podkarpackie Governor no. N-VIII.7820.3.4.2019 on the investment project implementation permit for flood protection structures titled "Łęg IV – extension of the left embankment at km 0+082-5+030 in the Gorzyce commune and the right embankment at km 0+000-5+236 in the Gorzyce commune", which allows for commencing the construction works, was obtained for the investment.
